






Migration and the Peopling of Mindanao

migration issues

- □ Realization/s that MIGRATION is not only international labor migration.
- □ Poverty, lack of economic opportunities, and livelihood opportunities as a major factor in the exodus of Filipinos abroad and local transit for refuge and/or survival.
- □ Feminization of labor migration and the gender-dimension of migrant worker exploitation and abuse

- Undocumented migrant workers; falsification of civil documents
- ☐ JOB MISMATCH. lack of available employment opportunities; inadequate employment and livelihood opportunities.
- ☐ Abandonment of families of migrant worker



migration issues

- OFW Remittance was recognized as vital and strategic contribution to the Philippine economy.
- Meager yet significant the REMITTANCE brought in by OFWs survived family members in IDP camps and emergency situation.
- ☐ The plights of the so-called stateless children (Sabah, Malaysia / ARMM)

- □ Phenomenon of migratory workers in the sugar cane industry which also identify and included child laborers.
- □ Development-induced migration in mining, agricultural plantations or shopping and commercial malls (urban displacement) in the city.



migration issues

- The absence of database system in tracking number of OFWs (documented or undocumented, active or returned). This is also the same emergencies/crises sistuation were tracking system of people in transit are not establish/installed thus resulting to poor prevention, protection intervention.
- the absence and/or lack of opportunity for regional participation /Mindanaoans on the discourse of MIGRATION patterns:
 Development and reactions (PEACE process, ASEAN Economic Reintegration 2015) and on the inclusion of migration to the Millenium SUSTAINABLE Development Goals

 - □ Butuan City was identified to have issues on alleged easy access to falsified personal documents – less stringent processing of passports/other travel documents





Recommendations

- ☐ The unification of intervention through convergence Government, private and CSOs
- ☐ To call on the national and local government units to include migration, whether inmigration or out-migration as integral part in the local development planning and policy developmenT
- □ Calling national government to sensitize its process of consultations to include MINDANAO voices and agenda partcularly on issues of migration, environment, peace and development.

- ☐ The need to enhance information dissemination on migration in Mindanao in the context of international labor migration, emergencies, and other induced displacements to generate awareness and concern.
- Creating protection mechanism to address abandonment of families of migrant workers.
